

## **Sneakerlah 2017 Lucky Draw terms & conditions**

The following terms and conditions shall apply to the Sneakerlah 2017 Lucky Draw (the “**Lucky Draw**”):

### **Eligibility**

1. The Lucky Draw is open to the all purchasers of General Admission or VIP tickets to Sneakerlah 2017.
2. Employees of Future Sound Asia Sdn Bhd (“**FSA**”), Shake Hands Sdn Bhd (“**SHSB**”), their immediate family members, and any other parties directly involved in organizing, promoting, or conducting the Lucky Draw are not eligible to participate in the Promotion.
3. FSA has the sole discretion to exclude any person from participating in the Lucky Draw without any obligation to furnish any notice and/or reason.

### **Participation in the Lucky Draw**

4. Attendees will be entitled to one (1) Lucky Draw entry for every General Admission or VIP ticket to Sneakerlah 2017 purchased.
5. A Lucky Draw entry stub will be removed from the attendee’s wristband and submitted as entry into the Lucky Draw upon entry to Sneakerlah 2017. The Lucky Draw entry stub will have a unique serial number which matches the serial number on the corresponding wristband.
6. Attendees are entitled to submit multiple Lucky Draw entries as per number of tickets purchased.

### **Conduct of Lucky Draw & Prizes**

7. There will be two sessions for the Lucky Draw. Both will be conducted on stage at Sneakerlah 2017. The first session will be on 7 October 2017 at 9:00 pm. The second session will be on 8 October 2017 at 8:00 pm.
8. There will be **102** winners picked during the Lucky Draw.

### **Prize Collection**

9. At each Lucky Draw session, a Lucky Draw entry stub will be picked randomly and the serial number on the stub will be announced on stage.

10. The winner must claim their prize on stage and produce the wristband which matches the serial number of the announced Lucky Draw entry stub in order to be eligible for the prize. The prize (excluding the Grand Prize) will be handed to them upon a successful match.

13. The color of the Vespa S 125 is at the sole discretion of Naza Premira Sdn Bhd upon the date of registration.

14. The prizes are not transferable, exchangeable for cash or any other items.

#### **General**

15. By participating in the Lucky Draw, the attendee is deemed to have accepted and agreed to be bound by these terms and conditions and any other instructions, terms and conditions that FSA or SHSB may issue from time to time.

16. FSA or SHSB shall not be liable to any persons in the Lucky Draw for any injuries, losses or damages in respect of, in connection with and/or arising from the Lucky Draw.

17. FSA and SHSB reserve the right to video, photograph and/or record the Lucky Draw, and publish any attendees' images and details for the purposes relating to the publicity of Sneakerlah 2017 without having to pay any fee or compensation to the attendees.

18. FSA and SHSB reserve the right to withdraw or cancel the Lucky Draw and to amend or change these terms and conditions at any time for whatever reason and without giving prior notice to the attendees. The decision of FSA and SHSB on all matters relating to or in connection with the Lucky Draw is final, and no correspondence will be entertained.

19. The attendee shall fully indemnify and hold FSA and SHSB harmless from and against any loss, damage, cost, liability or expense (including legal fees), whether direct or indirect, which FSA or SHSB incur in respect of, in connection with and/or arising from the attendee's breach of these terms and conditions.

20. In the event of any inconsistencies or discrepancies between the terms and conditions and the contents of any brochure, marketing and/or promotional materials relating to the Lucky Draw, these terms and conditions shall prevail.
